VI. Superintendent' Report/Update

Tom outlined updates:

- O School Street pump station upgrade is complete; and repairs caused by the storms are scheduled
- o Ferry Street; motor has been replaced
- O Webster #2 valve repair by July 1st.
- O Locating and marking for shut-offs in precinct 5 & 6
- o Budget: at 46 weeks we are at 87%
- O Equipment Maintenance will require at transfer by the end of the fiscal year. He, (Tom), Shawn and Dan met with Michael, Christine and Patrick to review the budget. At this time the Water Enterprise account is at 66%; the Solid Waste Enterprise account is at 83%; Wastewater Enterprise account is at 68%. We are in very good shape across the board.
- Winslow path has been completed.

John Vallier complimented the DPW for the clean-up process that has been done throughout the Town.

Shawn Patterson brought up the issue regarding stairs at Shepherds Path. Recent storms have shifted the rocks; as a result, the stairs will not be placed back. He indicated this is a safety issue.

Tom indicated that on Friday at 11:00 there will be a retirement party at the Highway barn for two DPW employees:

Michael Moran and Michael Meaney. Both will be retiring at the end of this month.
