3. Contract 2016-06 / Skate Park Change Order #2

Town Engineer, Rod Procaccino explained the change order is to salvage the stone pillars at the entrance of the skate park at the request of the Recreation Department. They asked if we could store them at the DPW Garage. The contractor will dismantle everything.

2. Enterprise Fund Update (going forward)

Steve addressed the issue. He did his best to try to have a meeting to solve the problem regarding methodology of the indirect costs. The "financial team" prefers to meet with staff and do not feel as though politicians should be at these meetings. At this point by December 15, we need to have a methodology regarding the indirect costs. It is important that the parties get together to discuss this issue.

Bob Shaughnessy stated that a year ago we tried to address the issue of indirect costs with the financial team. The Town Administrator has indicated that he does not have to meet with us, nor does the Town Treasurer or the Town Accountant to explain to us how they are coming up with their costs. Their methodology is into our budget for an x number of percentages of their overall budget. When Mike Valenti was on the Board we had put a whole letter together addressing our frustration because they would not even meet or talk with us. They still don't want to meet or talk with us to explain what they are doing. Tom stated we would not be in this predicament if they had responded to our request a year ago. Steve indicated that the interim treasurer has decided that there is no agreed upon methodology on expenditure of indirect costs. Now they want to meet and discuss this because an outside entity came in and identified the problem. Steve stated let's identify the problem, the methodology and fix the budget. Bob stated that we are trying to fix it so there is formal methodology that meets states standards.

We want to know how they arrive at the figures for the indirect costs to the Enterprise accounts. The financial team members will not allow Board of Public Works Commissioners to attend their meetings. This position is disturbing. An email sent from the Town Accountant to John Cusick stated that the meetings are for professionals only. Bob Shaughnessy stated he has "three master degrees". They did not even want Dan Bowen there, Business Administrator for the DPW.

Tom indicated that the Town Accountant is going on vacation for two weeks and we have deadlines to meet and she will not be available for questioning.
