Dave Carriere opened the meeting and reviewed the agenda which included, 2 items for action, Superintendent's report and executive session.

Roll call vote by Tom Reynolds: Dave Carriere aye John Cusick aye Robert Shaughnessy not on yet.

#### l. Items for Action

#### i. Contract Amendment to Foster Ave. Revetment Engineering Oversight

Tom presented details of the amendment. Project status; the construction project consisting of approximately 1050 LF of new and resetting of existing seawall toe revetment along Foster Ave. from just South of 3<sup>rd</sup> Road to 7<sup>th</sup> Road has been awarded. Construction will begin upon receipt of Chapter 91 License and anticipate to begin in approximate two months.

Proposal; amendment no8: GZA GeoEnvironmental Inc. of Hingham, MA will be conducting construction support services including resident engineering oversight on a part-time basis to ensure contract compliance. Staff recommends authorization of amendment no. 8 with part-time resident inspection and construction support services as proposed. Tom indicated that the Chapter 91 license should be available in a few days and should not have any problem for issue. This license is necessary to conduct work in the high velocity zones: is issued through the state.

**MOTION**: Tom Reynolds read the motion: to authorize amendment no. 8 to Contract 2015-05 Engineering Services Foster Avenue Seawall Repairs for construction support services for seawall stone toe revetment for and an amount of \$46,100 with GZA GeoEnvironmental Inc. and to authorize the Chairman or designee to execute the amendment when the documents are prepared.

#### ii. Discussion & Vote on Waste Hauler Contract for Curbside Waste & Recycling

Tom Reynolds opened the discussion. They have been negotiating with Republic Waste for the past six months for a new curbside and recycling contract. This is for a two year contract from July 1, 2020 through June 30, 2022. Town Counsel has reviewed the contract and determined previous concerns have been met.

**MOTION:** Tom Reynolds motioned that the Board extend the existing curbside rubbish and recycling pick-up contract and disposal with Republic Waste Contractors for the years 7/1/2020 to 6/30/2022 as amended.
