She said their priorities for acquiring land are in protecting Town drinking water and species habitats. Karen thanked the Board for funding a consultant to help write the 2018 plan and said it would be very helpful to hire again for the next update in 2023. Karen explained that the cost of appraisals has increased and having that money readily available is imperative. She would like to see that fund increased to allow for this.

K Richardson thinks the OSRP is very ambitious and impressive. He commented that a status plan showing what has been accomplished to date could be added. He questions if CPC could help fund an updated plan with use of administrative funds.

K O'Donnell explained that there is an up to date timeline section showing what is ongoing and what is expected within so many years.

K Cantwell thinks an application every couple of years to present at Town meeting may be a best to fund the plan updates.
