There are many different types of targets such as places of business which are considered "soft targets". The police department is working on developing the active shooter protocol in order to educate the schools, town departments and other groups about these types of emergencies. They continue to develop strategies to help victims cope with these situations. An active shooter situation typically only lasts a few minutes so timing is key. The police will talk to people today about how to best protect themselves from harm such as knowing where the exits are and locking or barricading a door with whatever you can. The newest thought is to run, hide, or fight. Each location and each emergency is a little bit different in how one would react.

Ideas still pending for Triad are; Public Forum Day, Emergency Devices, Nutritional Eye Health, Stroke Prevention, Defibrillator CPR Course and housing information.
