CALL TO ORDER: The meeting was called to order at 12:40 pm.

DISCUSSION: Christina brought 2 stacks of the File of Life's from the District Attorney's office and more have been ordered for future needs. The Fire Department has also ordered a large amount of the Files of Life for anyone who needs one. Chief Hocking said that it is a great help to Fireman when the Files are filled out. It helps direct them to pertinent information in the time of an emergency. Some housing complexes make certain that their tenants have the Files of Life. Perhaps we can do some outreach with the Senior Housing Complexes in giving out Files to those that do not have them. The Fire Department is willing to do a defibrillator training and CPR course for people that need certification at the Senior Center.

The SALT Council talked about homelessness emergencies. Marshfield has had their share of homeless clients that are elderly due in part to a lack of available and affordable housing for low income people. Becky talked about the Plymouth Networking Group that Liisa Budge Johnson belongs to. They have emergency resources that could be helpful in some situations. Another concern is elder abuse which sometimes ties into emergency situations. Terry Kortz from Old Colony Elder Services is interested in participating in Triad and talked to Christina Fitzgerald about attending in the future. Carol will send out an agenda to Terry for January The Norwell NVNA has also not attended recently but we hope they can attend future meetings as their input is valued. The SALT Council and Triad will not meet until next January due to the holidays.
