They would add a drainage easement from Progress Way to the rear of the proposed garage on Lot 25M. Mr. Guimond said that this would allow access for cleaning and repair of the riprap outfall of Lot 25M to the drainage structure on Lot D09-01-35.

They propose to change from a fore-bay to an underground oil and grit separator next to the garage building. This would address both the roof drain from the garage and the rear parking lot.
