The first change would add two new uses to the Table of Use, "For Profit Educational Use" and "Child Care Facilities." "For Profit Education Use" would allow a for profit school by special permit in the Industrial District. This change would allow educational use not covered by the Dover Amendment. "Child care facilities" would be permitted in all zoning districts. This change would make the Zoning Bylaw consistent with State Law. The last proposed change would amend the Zoning Bylaw to change the name of the "Board of Selectmen" to the "Select Board" and refer to the "selectmen" as members of the "Select Board."
