The abutter notices were sent out but the applicant's engineer did not flag the area of the stones to be removed.

Crystal Gould, 995 Union Street, asked if the poison ivy along the wall would be removed. The applicant said it would be.

Suzanne Travers, 38 Corn Hill Lane, questioned if the new driveway would be used for trucks from the farm. The applicant explained that the driveway is not associated with the farm. The driveway is for the new lot and will be residential.

Mr. Biviano made a motion to approve the scenic road project for 37 Corm Hill Lane subject to the location of the changes to the store wall being confirmed before the work begins. Ms. O'Donnell seconded. Ms. O'Donnell reminded that Board that the wall should be dry set with no new stones. The vote was Mr. Cantwell, Aye; Ms. O'Donnell, Aye; Mr. Monaco, Aye; Mr. Pappastratis, Aye; and Mr. Biviano, Aye. The vote was 5-0.
