Public Hearing Site Plan Review/WRPD Special Permit (Frasca Plain Street) D10-02-16

Attorney Jeff De Lisi and Gabriel Padilla from Grady Consulting presented on behalf of the applicant, Ryan Frasca.

Attorney De Lisi stated that the site was 2 ¾ acres adjacent to 795 Plain Street. It is located in the I-1 industrial District. The front portion of the site is located in the Water Resource Protection District (WRPD). The proposed storage facility has a 43,000-ft² footprint and has two floors. The septic system will be located outside the WRPD. After the April 2023 Annual Town Meeting zoning change, self-storage is allowed as of right in the I-1 district. The WRPD prohibits storage of hazardous materials. The building commissioner provided a determination that the site will require 20 spaces. The Planning Board is the site plan approval authority when acting as the special permit granting authority in the WRPD. The project must meet the design standards of the WRPD. The application has been reviewed by Pat Brennan and Ed Eichner, the Planning Board's consultants.

There are two subsurface systems, one in the WRPD and one out if the district. The septic system has been designed for 15 employees but there will only be 3 employees. The dumper will be enclosed in the back of the building.

The applicant submitted draft language notifying the tenants regarding the prohibition of hazardous materials to be included in the rental agreements. This draft language needs to be reviewed by Ed Eichner.
