Present: James J. Fitzgerald, Chairman; Joseph E. Keller, Vice-Chair, Michael G. Bradley, Clerk; Michael A. Maresco, Town Administrator and Phil Tavares, Police Chief The Board members were a little late getting to the meeting so they decided to meet at their table in the auditorium.

Mr. Fitzgerald opened the meeting at 6:45 p.m.

<u>Michael Lepage – One Day Wine & Malt License – Historic Winslow House June 2, 2018</u> (wedding) - Mr. Fitzgerald read the request from Mr. Lepage. Chief Tavares said that they had called him and he will get in touch with them to make sure they comply with all the rules. Mr. Bradley moved, seconded by Mr. Kelleher to approve the One Day Wine & Malt License for Mr. Lepage contingent upon approval of the Police Department. The vote was unanimous.

<u>Permission to hold parade, cook-out and children's dances – Rexhame Beach Association</u> – Mr. Fitzgerald mentioned the request and asked if the Police Department had approved. Mr. Bradley moved, seconded by Mr. Kelleher to approve the use of the Town Hall lawn for their annual church fair from July 12- July 15, 2018. The vote was unanimous.

<u>Permission to hold Woodsy's 7th Annual Walk on July 15, 2018</u> – Mr. Fitzgerald read the request to hold Woodsy's 7th Annual Walk on July 15th. Mr. Maresco stated that they have approval from the Police Department. Mr. Bradley moved, seconded by Mr. Kelleher to approve the request for Woodsy's 7th Annual Walk on July 15, 2018. The vote was unanimous.

<u>David Crest – One Day All Alcohol License – Daniel Webster Estate – June 7, 2018</u> – Mr. Fitzgerald read the request from Family Crest Catering for a One Day all Alcohol License for the Chamber of Commerce Citizen of the Year Event. Mr. Fitzgerald noted that he had his certificate of insurance. Mr. Bradley moved, seconded by Mr. Kelleher to approve the One Day All Alcohol License for Family Crest Catering on June 7, 2018 from 6:00 p.m. – 8:00 p.m. The vote was unanimous.

Mr. Fitzgerald moved seconded by Mr. Kelleher to adjourn the meeting at 6:50 p.m. to the Special Town Meeting in the High School Auditorium. The vote was unanimous.
