<u>Wicked Women Makers Market</u> – Michael Maresco said that the applicants have secured the Winslow House for this outdoor event which is scheduled to take place on November 28, 2020. <u>Mounces Meadows Farmers License Agreement</u> – Michael Maresco said that Bob Galvin has approved this license agreement facilitated by the Conservation Commission allowing Ronnie Simon to farm the town-owned land known as Mounces Meadow. Mike Bradley moved, seconded by Steve Darcy, to approve and sign this agreement. The vote was 2:0. Roll Call vote: Mr. Bradley – aye; Mr. Darcy - aye.
