

MINUTES – SELECTMEN’S MEETING

Friday, March 26, 2021

Remote Meeting

Mr. Bradley moved, seconded by Mr. Rohland, to open the meeting at 1:00 p.m. The vote was unanimous. Roll Call vote: Mr. Bradley – aye; Mr. Rohland – aye; Mr. Darcy - aye.

Reappointment of Animal Inspectors – Michael Bradley moved, seconded by Christopher Rohland, to reappoint Alyssa Ryan and Griffin Webb as Animal Inspectors for the Town of Marshfield for terms starting on May 1, 2021 and expiring on April 30, 2022. The vote was unanimous. Roll Call vote: Mr. Bradley – aye; Mr. Rohland – aye; Mr. Darcy - aye.

Hours for Municipal Election – Town Clerk Narice Casper appeared remotely before the Board and requested that the polling hours be limited to 9:00 a.m. until 3:00 p.m. for the municipal election. Early In-Person Voting – Michael Maresco reviewed the proposed hours for early in-person voting at Town Hall. After a brief discussion, Michael Bradley moved, seconded by Christopher Rohland, to approve in-person early voting at Town Hall from April 21, 2021 through April 28, 2021 on Tuesday, Wednesday and Thursday from 8:00 a.m. until 4:00 p.m., Friday from 8:00 a.m. until 12:30 p.m., Saturday from 9:00 a.m. until 1:00 p.m., Sunday from 12:00 p.m. until 4:00 p.m. and on Monday April 26 from 8:00 a.m. until 5:00 p.m.. The vote was unanimous. Roll Call vote: M. Bradley – aye; Mr. Rohland – aye; Mr. Darcy - aye.

Mr. Bradley moved, seconded by Mr. Rohland, to adjourn the meeting at 1:10 p.m. The vote was unanimous. Roll Call Vote: Mr. Bradley – aye; Mr. Rohland –aye; Mr. Darcy – aye. There was no executive session held.
