

**MINUTES – SELECTMEN’S MEETING
TUESDAY, APRIL 28, 2015 AT 6:45 P.M.
MARSHFIELD HIGH SCHOOL – ROOM 172**

Mr. Hall opened the meeting at 6:45 p.m.

Mr. Robbins mentioned that he would be recusing himself from one of the beach hire votes tonight as it is a family member but would be voting on all the others.

Beach Hires - Mr. Hall read the memo from Lt. Sullivan regarding the returning beach hires from last year. Renewal of Robert Biagini Earth Removal Permit – Mr. Hall read the letter from Robert Biagini and mentioned that this is an annual permit. Mr. Hall also stated that there was also a load count report attached, certificate of liability insurance and a memo from the Board of Health regarding groundwater determinations at the Biagini sand/gravel pit. Mr. Hall moved, seconded by Mr. Robbins to approve the annual Earth Removal Permit for Robert Biagini. The vote was 2-0. Mr. McDonough was absent.

Mr. Hall motioned to adjourn the meeting at 6:57 p.m. to the Town Meeting floor in the auditorium.
