Ben Garman of Shoreline Aviation reported that the Electric Vehicle chargers for the airport have been installed but are not yet active. The chargers are expected to be activated by the end of May 2023. Garman turned the report. over to Commissioner Suffredini who gave an update on the commemorative bench for commissioner Bud Francis has been completed and the commemorative plaque has been. installed. After meeting with the spouse of late commissioner Francis it was decided the dedication ceremony will be held on Saturday June 10, 2023, at 11AM
