CALL TO ORDER: The meeting was called to order at 12:35 pm.

The Council on Aging is coordinating a fire drill schedule with the Fire Department. There will be one in the spring and one in October which will coincide with Fire Safety month.

The subject of hoarding was brought up as there was a recent report of a potential problem. This affects the resources of public safety. The Old Colony Elder Services is providing workshops for hoarders in Brockton and Plymouth. The SALT Council talked about concern over whether or not hoarders would actually attend the sessions. It is a complex problem with many aspects to consider. There was an article in the ledger about a homeowner in Hingham that had a hoarding issue which highlighted many important aspects of the problem. There is also a television show that presents various case studies on hoarding. The SALT council thought that perhaps we could offer a program on hoarding for professionals and families. Perhaps we could include a therapist, a representative from Old Colony Elder Services and a professional company that provides a clean-up service. A video showing a real example would also be helpful.

The Council on Aging will be providing a "Savvy Caregiver Series" for six weeks in collaboration with South Shore Elder Services. It will last six sessions and will offer training and support to family members caring for their loved one. The sessions will start on Wednesdays, March 28th through May 2nd from 5:30 to 7:30
