At a meeting of the Marshfield Open Space Committee ("the Committee"), Chairperson Karen O'Donnell (KO), members Sue MacCallum (SM), Craig C. Hannafin (CCH) and Susan Caron (SC) were present on the Zoom meeting. Chris Ciocca (CC) entered meeting at 7:15 pm. Kevin Cantwell (KC) entered the executive session at 7:39 pm.

Steve Goodhue from the Recreational Trails Committee and Gary Pina, Chair of the Recreation Commission, were also present on the Zoom meeting.

At 7:08 pm, KO made a motion to open the meeting. Seconded by CCH. **ROLL CALL: KO yes, SM yes, CCH yes and SC yes.**

<u>Committee Membership:</u> KO introduced Steve Goodhue & Gary Pina. Both were invited to attend and meet with members to determine their interest in the open representative seat.
