If the Board feels there are too many articles, we could postpone Article D, which moves the PMUD to a different section of the Bylaw. The package has been reorganized to group similar articles are together for the warrant.

Mr. Pappastratis would like to hold less time sensitive articles. Ms. O'Donnell initially agreed. However, after discussion, the Board decided to move ahead with all 18 articles. Mr. Guimond suggested that the Board could pull the any of the articles at Town Meeting if we receive a lot of negative feedback.
