#### Board discussion on draft MBTA Communities bylaw and Accessory Apartment Bylaw

Mr. Guimond provided a brief overview of the proposed zoning articles.

- MBTA Zoning. Changes since previous draft include removing the section to allow higher density by special permit; removing the existing standards on page 5;, removing reference to GATRA pullover on page 7;
- 2. Accessory Apartments Changes include the size of the units. Currently recommending 900 sq. ft.
- 3. Building Commissioners suggested change to Section 13.05 flood proofing to not allow breakaway walls in a barrier beach
- 4. Table of Use corrections for OSRD and ARAV
- 5. Changes to reference Housing Trust and EOHLC
- 6. Changes to the Table of Use to include accessory apartments
