### **Old Business**

- > **Eversource Lease** – in review, Ned to touch base in July – update at July meeting
- > **Furnace Brook Watershed, New Trail** – Ned gave an update in regard to the new Furnace Brook Trail. 2 loops and a bench. Walked with Bill, Jeff, and Jason Zimmer. Need a footbridge, fall project. Notice of Intent to St. Christine's. July update. NEMBA to give us bridge?
- > **You are Here, Trail Guideline and Horse Etiquette signs** – Steve gave an update that we all signs except Standish Street are installed. Brenner will install Standish Street signs when we are ready at no charge since we paid him for this service. Extra Horse Etiquette signs (10) will be held by Greg Guimond until a future date.
- > **Gangway (Damon's Point)** – no update
- > **NEMBA Fall mountain bike race** - moving forward with mountain bike race
- > **Trail Ambassador work** – great turnout at Jose Carreiro woodland – 22 people showed up ad the social media response has been very positive
- > **Rail Trail / Bridle Path map update** – Angela getting out to proof and went over proofs. Look good.
- > **Kiosk # 8, Saint Christine Church** – Tom to start work in the fall
- > **CRS - Couch Beach** – Table for Bill
- > **Pratt Farm** – Steve tried to get \$2,000 for Pratt signage, from Open Space but was unsuccessful. Town Counsel will no longer cross project fund movement.
- > **PED Lights, grant** – not approved
- > **Red Gold Farm** – everything is filed, 20 day waiting period – 23 houses

- **New Business:**
