# SPOTLIGHT ON EXCELLENCE: GWS Early Intervention in Literacy

Principal Hubbard introduced reading specialists Pam Roberts and Nicole Silva along with teachers Christina Jacobucci, Maura Hayes, and Hannah Coletta. Ms. Roberts and Ms. Silva discussed their team approach to planning and instruction along with their intervention schedule. In grades 1 and 2, tier I instruction includes Fundations where students work in a group specific to their needs in collaboration with the classroom teacher, special education teacher, specialist, and classroom aide. Testing results were shared highlighting the advancement of students as a result of this program.

#### III. NEW BUSINESS

# **McKinney Vento Update**

McKinney Vento liaison Robynne Ryan-Lambert updated the SC on the overwhelming support she received for the #66 homeless students and #25 students in foster care. She highlighted the Marshfield Community Rib Cook-Off Committee and their very generous \$22,000 donation. The MCRCO Committee were in attendance.

Mrs. Brait commented on the amazing partnership between the community and MPSD. Supt. Granatino praised Mrs. Ryan-Lambert for the partnerships she created between the schools and town organizations.

## **Acceptance of Donations**

The Edwin Philips Trust awarded a \$25,000 grant to renovate the life skills classroom for special education students at FBMS.

# FY'24 Operating Budget

Supt. Granatino presented the proposed FY24 budget. Mr. Miller added that 85% of our budget is salaries. The budget is based on the financial plan and takes the 5 pillars of the strategic plan into consideration. One concern is the requested 14% increase for out of district placements along with anticipated utility increases. Six proposed needs based enhancements total \$450,000. The town projects a 3% increase and MPSD has requested 5%. Meetings continue with the budget subcommittee.

Ms. Boyd asked the status of Title I funding (federal grant). Asst. Supt. Martin answered that prior years \$500,000 was reduced to \$250,000 as FY21 census numbers reflect fewer families in poverty (currently 4.5%; 5% needed for additional funding).

# **Early Childhood Tuition**

Mr. Miller submitted a proposed increase in preschool tuition form \$2,500 to \$2,750 as a 1<sup>st</sup> read.

## **Driver's Education Tuition**

Mr. Miller submitted a proposed increase to the driver's education tuition from \$675 to \$825. This is a self-funded program and the increase would take effect in March.

**MOTION:** Mrs. Brait moved to approve the increase in driver's education tuition from \$675 to \$825. Mr. Greer second. VOTE: 3-0-0

## MHS Library Book Surplus

Mr. Miller discussed the list of books the MHS library recommended be sold or donated.

**MOTION:** Mrs. Brait moved to declare the listed books as surplus. Mr. Greer second. VOTE: 3-0-0

#### IV. FUTURE MEETINGS

A School Committee meeting is scheduled for January 24<sup>th</sup> at Seth Ventress Auditorium including the Public Budget Hearing.
