V. OLD BUSINESS

FY'19 Budget: Mr. Miller reviewed the FY'19 Draft Financial Plan with the Committee. A budget number needs to be voted per the Town Charter. Committee and Administration will continue to have discussions with the Town, Advisory Board and Board of Selectmen.

We are still waiting for the health insurance number from Mayflower and Chapter 70 number.

Mrs. Boyd noted Full Day Kindergarten benefits are clear. Marshfield Public Schools owes it to the students of Marshfield to support Full Day Kindergarten.

Mrs. Campbell noted prior concerns from parents regarding Full Day Kindergarten for all students.

Mr. Greer noted Full Day Kindergarten should be affordable for everyone.

Mrs. Church noted the FY'19 Financial Plan has great priorities for the students and families of Marshfield, and the Committee looks forward to advocating for the school district with the Town of Marshfield.

Mr. Miller noted the Advisory Board Budget Hearing is on March 27 and Town Meeting is on April 23.

Committee thanked the Budget Subcommittee for their hard work on the FY'19 Educational Budget.

MOTION: Mrs. Campbell moved to approve the FY'19-FY'23 Draft Financial Plan in the amount of \$1,166,488 as presented. Mrs. Boyd second. VOTE: 5-0-0.

MOTION: Mrs. Boyd moved to approve the FY'19 Educational Budget as presented in the amount of \$49,617,402. Mrs. Church second. VOTE: 5-0-0.

<u>Coordinated Program Review:</u> Asst. Supt. Dupuis discussed the DESE visit. This is the last year CPR will be done every six years. December visit involved a record review of 43 student records from Special Education and ELL students. DESE noted record review was impressive.

DESE interviewed 40 staff and SEPAC on January 10, 11 and 12 that included all seven principals, observing our facilities, interviewing staff, parents and SEPAC Chair.

Surveys were sent out to 700 Special Education parents, translated in several languages.

VI. NEW BUSINESS

<u>Transportation Contract:</u> Mr. Miller reviewed new three-year contract. Only received one bid response from Totman Enterprises in Scituate. Fiscal implications are almost a 16% increase (cost of gas, salaries, buses). Totman has been a fantastic transportation provider for the Town of Marshfield.

The contract is for three years with the option to extend for two more years, effective July 1, 2018 through June 30, 2021.

Marshfield has the option of dropping routes or buses. Cameras on buses will be increased from three buses to six buses.

The Transportation Contract will come back to the Committee on February 6th for a second read.

<u>Veterans Donation:</u> Supt. Granatino noted check from Veterans of Korean War in the amount of \$250 for the Furnace Brook Middle School.
