<u>MCAD Pregnant Workers Fairness Act</u>: This is a new policy is being reviewed by Counsel. Supt. Granatino has spoken with Massachusetts Association of School Committees and their draft is not finalized as yet. Policy will return to Committee for a second read and vote on April 23.
