V. OLD BUSINESS

2020 – 2021 Academic Calendar: Supt. Granatino presented the 1920-2021 academic calendar for a second read, beginning prior to Labor Day on September 7, 2020 and closing on June 10, 2021. The Presidential Election is November 3, and our students will not be attending school.

MOTION: Mr. Costello moved to approve the 2020-2021 academic calendar as presented. Mrs. Boyd second. VOTE: 5-0-0.

VI. NEW BUSINESS

WE ARE MARSHFIELD: Mrs. Kurmin and Mrs. Pozerski outlined the background of We Are Marshfield and showed a slide show of the 2018-2019 event. A total of 210 MHS seniors, comprising 31 teams went out to 42 sites within the Marshfield community on April 26 with 75 volunteers assisting. Our seniors worked at schools, public and historic landmarks, churches, and private residences.

Some of our senior citizens wish to give back to the students. We Are Marshfield suggests a donation to Grad Nite Live. The towns of Norwell and Hingham are now sponsoring a similar community event day for their seniors.

MOTION: Mr. Costello moved to approve six School Improvement Plans as presented. Mrs. Campbell second. VOTE: 5-0-0.

FY'20 Budget: Mr. Miller presented updated on 2020-2024 Draft Financial Plan. Mrs. Scolaro presented update on Special Education Reorganization of positions. We are re-engineering our positions to be proactive rather than reactive.

All schools have worked together on this reorganization of positions. Changes will allow MPSD to move forward on FBMS Assistant Principal, two Special Education Teachers at FBMS, K-12 Mathematics Coach, Elementary Health Teacher, and district-wide Behavior Specialist. There is no change in the voted and approved budget.

MOTION: Mr. Costello moved to approve the following positions as presented by Administration: FBMS Assistant Principal, K-12 Mathematics Coach, two Special Education Teachers at FBMS, Elementary Health Teacher and district-wide Behavior Specialist. Mr. Greer second. VOTE: 5-0-0.

Substitute Rates: Mr. Miller presented changes in the substitute rates for the 2019-2020 academic year. This \$25,000 has already been factored into the FY'20 budget voted in April, 2019. Administration is looking at permanent custodial substitutes.

MOTION: Mr. Costello moved to increase current \$12 per hour substitute rates to \$13 per hour; increase current \$84 per day substitute teacher rate to \$100 per day; increase current \$12 per hour custodial substitute rate to \$15 per hour as recommended by Administration. Mrs. Boyd second. VOTE: 5-0-0.

VII. FUTURE MEETINGS

Mr. Costello congratulated the Class of 2019, and special congrats to Ben Greer and Owen Boyd.
