### VI. NEW BUSINESS

<u>Educational Stability Program Review:</u> Marshfield has been selected for this review (Tiered Focused Monitoring. Amy Scolaro and her staff will be working on this review, due June 5, 2020. DESE will visit Marshfield to assess our programs in the fall of 2020.

Mr. Greer questioned cost. Marshfield produces the documentation requested in the review, thereby meeting all DESE regulations.

School Resource Officers: Supt. Granatino noted the Marshfield Police Department and Selectmen are looking at ways to enhance our school resource officers. Looking at dedicated resource officers for Furnace Brook Middle School and eventually our five elementary schools, without impacting our educational budget. This would enhance our safety and security. The Marshfield Police Department works well with our school administration.

<u>Transportation Committee</u>: Committee consists of Sean Costello, Lara Brait, Tom Miller, three principals – elementary, middle and high school. Survey will go out to all families. Looking at other districts that have a transportation fee. Marshfield currently has four tiers of transportation – we are looking to cut down to three tiers. Committee discussed start times.

K-6 – all beyond two miles is mandated transportation 7-12 – voluntary transportation All within two miles is voluntary transportation

Marshfield is only one of two surrounding towns not charging a transportation fee – other town is Hingham. Committee is meeting again later this week.
