V. OLD BUSINESS

MCTV Memorandum of Agreement: Supt. Granatino highlighted edits. Parking facilities are specified as five spaces. After school dismissal, many more parking spaces are available. MCTV also read MOA and noted clarification of Studio A. MCTV also noted the expiration date of ten years (2023). MCTV License with cable expires 11/5/17. This license is through the Board of Selectmen.

Mrs. Church requested only five spots be designated to MCTV due to increased parent drop offs and emergency vehicle access. Additional spots are available after 3 p.m.

MOTION: Mr. Greer moved to approve the Memorandum of Agreement with MCTV and Marshfield Public Schools as amended. Mrs. Campbell second. VOTE: 5-0-0.

VI. NEW BUSINESS

Rexhame Beach Playground: Mrs. & Mrs. Godding introduced themselves to the Committee. Mr. Costello gave Committee some background and history of the playground proposal. Even though this is not official school business, Mr. Costello wished to bring this forward since the toddler playground will be used by young children in Marshfield.

Mr. & Mrs. Godding requested the support of the School Committee and explained the history and their love of Rexhame Beach. The playground is a gift to Marshfield in memory of their son. The playground has 100% private funding with no impact to parking at Rexhame Beach (space is beside the snack shack). They have secured a security system at no cost to the town. They currently have funding to purchase the playground, have it installed by Child Scapes, and funds for maintenance and future improvements. The Goddings will go before the Selectmen next week to request their support. The playground will be for toddlers two to five years old.

The Committee thanked the Goddings for their effort. Mr. Costello must abstain from any vote since he is on the Board of Directors.

MOTION: Mr. Greer moved to support the Matty K's Seven Seas Playground. Mrs. Campbell second. VOTE: 4-0-1. (Mr. Costello abstain)

Marshfield Education Foundation: Ms. Elizabeth Burns and Ms. Marie Kurmin noted the Marshfield Education Foundation (MEF) gave just over \$82,000 – 19 awards – to MPSD staff at the awards ceremony. MEF received 32 grants this year. The awards touched all schools – every school has received between 15% to 17% of funds. MEF has given \$601,000 to Marshfield Public Schools. The MEF gives constructive feedback to all building principals.

Some of the grants included:

- Social Emotional Therapy Dog for MHS
- Funds of \$23,000 to three elementary schools to align Journeys with Readers Workshop
- STEAM – second generation

MEF will meet as a board over the summer to discuss how MEF can best impact large and small initiatives within the school district.

The St. Patrick's Day 5K is the biggest fundraiser. MEF is spearheading a new fundraiser called Circus Smirkus in July.

MOTION: Mr. Greer moved to accept the total grant amount of \$81,841 from the Marshfield Education Foundation. Mrs. Church second. VOTE: 5-0-0.

South Shore Educational Collaborative:

MOTION: Mr. Greer moved to vote Supt. Granatino as the representative to South Shore Educational Collaborative. Mrs. Boyd second. VOTE: 5-0-0.
