SPOTLIGHT ON EXCELLENCE: FBMS One Book One School Initiative

Principal Kemmett & Asst. Principal Lisa Lynch presented a slide show on the One Book One School (OBOS) initiative at FBMS. The program promotes literacy along with a sense of unity and community within their building. The book selection for the 9th year of the initiative is <u>Squint</u> by Chad Morris and Shelly Brown. <u>Squint</u> incorporates many life lessons including seeing the good in those around you. Book talks are scheduled for parents on 8/11 and students on 8/12. Following their presentation, a copy of <u>Squint</u> was presented to all SC members and Superintendents.

Mrs. Brait expressed gratitude that all who work at FBMS are involved in the OBOS initiative. Mrs. Campbell added that the themes of the book include situations that parents also encounter. Mr. Costello expressed his excitement waiting for each years' OBOS selection.

Supt. Granatino updated the Committee on the following:

- LED lighting will be installed at FBMS thanks to town funding

- Conversations continue with SSVT and Supt. Hickey regarding steps needed to enter a partnership with them. Becoming a member school requires a vote at Town Meeting
- MPSD chose not to wear masks during summer school. For the fall, current state guidance is that masks and distancing will not be required
- MHS football planning 1st responders night for 9/10
- Principal MacNeil had meet and greet with teachers and planning a popsicle gathering with students on 7/22

MPSD Leadership Retreat

Supt. Granatino highlighted the work accomplished by leadership including:

III. NEW BUSINESS

Substitute Rates

Asst. Supt. Miller presented current and proposed substitute rates. The proposed increase would amount to approximately \$46,000/year. Asst. Supt. Miller amended the proposed sub-custodian rate in the packed from \$18 to \$20 based on ongoing contract negotiations.

Mr. Greer asked if the increase would take effect immediately. Asst. Supt. Miller stated that the rate change would take effect 9/1/21. Mr. Greer stated he would abstain from vote as his children are MPSD substitutes.

MOTION: Mr. Costello moved to approve the proposed substitute rates as amended. Mrs. Campbell second. VOTE: 4-0-1 (Greer abstain)

MCTV Update

Jonathan Grabowski of MCTV updated the SC on their collaboration with MPSD and the community. They are currently in the 7th year of a 10 year lease at MHS and 13th year of an internship partnership with MHS. A grant program is available to MPSD educators up to \$5,000/year. The elementary innovation specialist applied for the grant and purchased a drone. During FY21 there were #8,000 hours of community programming including #93 sporting events, NHS Induction, Senior Night Outside, Senior Awards, Music Awards, and Graduation.

Ms. Boyd expressed appreciation for the partnership with MPSD and thanks that MCTV was able to share what was happening in schools with the community. Mrs. Brait added that MCTV is an essential community resource.
