Stephen Darcy moved, seconded by Lynne Fidler, to open the meeting at 6:35 p.m. The vote was 2:0. Mr. Maresco noted that James Kilcoyne was not attendance due to a personal commitment.

Request to Waive Fees – Building Department – Stephen Darcy moved, seconded by Lynne Fidler, to waive all plumbing and gas permit fees for Coastline Plumbing and Heating relative to the replacement of a hot water heater for the Wastewater Treatment Plant located at 200 Joseph Driebeek Way. The vote was 2:0.

Application for Annual Peddlers License – Stephen Darcy moved, seconded by Lynne Fidler, to approve a peddler's license for David Casey dba Wicked Flavah Food Truck for the operation of a mobile food truck on Town roads or at events in the Town of Marshfield with permission of the event organizer, pending approval from the Board of Health. The vote was 2:0.

Application for Temporary Entertainment License – Stephen Darcy moved, seconded by Lynne Fidler, to approve a temporary entertainment license for Vicky Lynch of the Marshfield Friends of Animal Shelter for the Rockin' at Rexhame concert series at the Rexhame Beach parking lot on Saturday, June 24, 2023 with a rain date of July 1, 2023; Saturday, July 15, 2023 with a rain date of July 29, 2023; and Saturday, August 12, 2023 with a rain date of August 19, 2023 from 6:00 p.m. until 8:30 p.m., pending approval from the Building Department, Board of Health and Fire Department. The vote was 2:0.

Commercial Parking Permit – Green Harbor Lobster Pound – Stephen Darcy moved, seconded by Lynne Fidler, to renew the commercial parking permit for the Green Harbor Lobster Pound located at 131 Beach Street for 46 parking spaces at \$24 per space for a total of \$1,104, contingent on all taxes and fees owed to the Town being paid in full. The vote was 2:0.

Ragnar Relay – Stephen Darcy moved, seconded by Lynne Fidler, to approve the request to route the Ragnar Relay road race through the Town of Marshfield on Saturday, May 20, 2023 from 4:30 a.m. until 3:30 p.m., pending approval from the Marshfield Police Department. The vote was 2:0.

Beach and Back 5k and Half Marathon – Stephen Darcy moved, seconded by Lynne Fidler, to approve the request from Anne Marie Winchester to hold the Beach and Back 5K and Half Marathon on Sunday May 14, 2023 starting at 7:30 a.m. in Brant Rock, with a detail of two EMTs that will follow the runners along the half marathon route in a vehicle and a similar amount of police details as last year. The vote was 2:0.

Carolina Hills Mountain Bike Classic – Stephen Darcy moved, seconded by Lynne Fidler, to approve the request from the Recreation Trails Committee to hold the 2nd annual Carolina Hills Mountain Bike Classic on Sunday, June 25, 2023 from 8:00 a.m. until 4:00 p.m. using existing trails throughout the Carolina Hill Reservation. Trails will be cleaned at the end of the race, race is limited to 150 riders 12 years and older. Proceeds to benefit the Recreational Trails Committee, pending approval by the Police, Fire and Conservation Commission. The vote was 2:0.

Temporary Liquor License – North River Arts Society – Stephen Darcy moved, seconded by Lynne Fidler, to grant a one day wine & malt pouring license to Julia Driscoll, North River Arts Society to be used at the GAR Hall on April 15, 2023 from 6:00 p.m. until 9:00 p.m. for the opening reception of an art exhibit, pending approval by Police and Fire. The vote was 2:0.
