## INSTRUCTIONS FOR CHAIR/VICE REMOTE PARTICIPATION MEETING

- 1. Chair: Announce that meeting is being conducted pursuant to Executive Order dated March 12, 2020 suspending certain provisions of the Open Meeting Law, Gen. L. c. 30A §20 et seq., the remaining provisions of Gen. L. c. 30A §20 and 940 CMR 29.01 et seq. Indicate this rule is in effect during the state of emergency declared by the Governor.
- 2. Announce that the meeting is being recorded, if it is, and by what means, and note that individuals may record any public portion of the meeting provided that they announce who they are and that they are recording it and by what means. Recommend that meetings be recorded.
- 3. Announce that the meeting is being conducted remotely and that all votes taken during the meeting will be by a role call vote. Members of the board, commission or committee who are participating remotely must affirm that they are alone and to advise if anyone else is listening in on their line from their location. The meeting will be suspended on a temporary basis if the members participating remotely are disconnected for any reason and will resume after the member is reconnected with the meeting. In the case of a public hearing, where state or local law allow public participation (i.e. zoning board, planning board, conservation commission, board of health, selectmen, assessors, dpw, etc.), the applicant, any parties in interest and the public shall be permitted to participate remotely and the meeting will be suspended if the applicant or parties in interest become disconnected and will resume after the persons are reconnected.
- 4. Request that persons (1) turn on mute buttons while listening or waiting to speak, (2) wait their turn before speaking and be recognized by the chair and (3) when speaking speak first by identifying themself by name and address on the first time speaking and thereafter by name and then their comments on any subsequent communication.
- 5. Announce that all documents referred to in the meeting are or will be available on the website of the town, board, commission or committee as soon as practicable.
- 6. Announce that if the event that the chair, after a warning, experiences any unreasonable disruption or interference caused by a person attending or participating during a meeting, the chair may silence that person or terminate their continued participation in said meeting.
- 7. Announce that a transcript or recording of the meeting or hearing will be prepared and filed with the Town Clerk as soon as practicable after the close of the meeting or hearing and that this will also available on the town's website.

NB: Same rules apply during executive sessions with proper motions.
