**#20-77: Patrice Murphy:** The Petitioner is seeking a Special Permit in accordance with §305-10.12 of the Marshfield Municipal Code to construct a 2' x 12' shed dormer on the back of the dwelling on the property located at **228 Careswell Street** which is further identified on the Assessors' Maps as being on parcel L05-31-17 and is located in an R-3 zoning district.

**#20-78: Robert and Susan Herlihy:** The Petitioners are seeking a Special Permit in accordance with §305-10.12 of the Marshfield Municipal Code to construct a one (1) story 8'4" x 9' bump-out addition on the side of the dwelling on the property located at **675 Ocean Street** which is further identified on the Assessors' Maps as being on parcel K12-08-10 and is located in an R-3 zoning district.
