A Public Hearing will be held by the MARSHFIELD ZONING BOARD OF APPEALS at Marshfield Town Hall, 870 Moraine Street, Marshfield, MA in Hearing Room 2 on **Tuesday, June 25, 2019** at 7:00 P.M. to consider the following:

#19-44: Frank Pomposelli: The Petitioner is seeking a Special Permit in accordance with §305-9.02 of the Marshfield Municipal Code to construct a 3.5' x 15.4' addition on the existing single family dwelling on the property located at **58 Circuit Avenue West** which is further identified on the Assessors' Maps as being on parcel K11-29-05B and is located in an R-3 zoning district.

#19-45: Christopher Ryan and Stephen Halko-Sheehan: The Petitioners are seeking a Special Permit in accordance with §305-10.12 of the Marshfield Municipal Code to construct a 12' x 27' addition and extend the deck 16' along the line of the existing deck on the property located at **61 Chandler Drive** which is further identified on the Assessors' Maps as being on parcel I09-03-09 and is located in an R-2 zoning district.

#19-46: Conor and Cassandra O'Donovan: The Petitioners are seeking a Special Permit in accordance with §305-10.12 of the Marshfield Municipal Code to rebuild the front entrance/landing deck which will be 3' x 6' and to level off the deck with a 4' x 19.9' wrap around to replace the existing ramp on the existing single family dwelling on the property located at **11 Farragut Avenue** which is further identified on the Assessors' Maps as being on parcel L11-05-07 and is located in an R-3 zoning district.
