**B.** #19-40: Andrea Ryan: The Petitioner is seeking a Special Permit in accordance with §305-9.02 of the Marshfield Municipal Code to construct a 7' x 19.3' cantilever deck on the ocean side of the property located at 212 Foster Avenue which is further identified on the Assessors' Maps as being on parcel L10-24-05 and is located in an R-3 zoning district.
