Residential Spraying Monday, June 1, 2021 - October 2021.

Plymouth County Mosquito Control Project accepts requests for adult mosquito control from residents. Residents can call up to eight times per season to have their yard sprayed. The spray used will kill the mosquitoes in the area at the time that they spray and is not a preventative. Residents must call, fax or mail each time they have a mosquito problem.

Pesticide applications are made via an ultra-low volume sprayer that is on the back of a pickup truck. Weather permitting; the sprayers are operating 2 AM to sunrise each weekday.

Re: **Notification of Mosquito Adulticide Applications**

Please be advised that the Plymouth County Mosquito Control Project will begin truck based adulticide applications **on June 1, 2021 through October 2021**. Spraying is conducted between 2AM and sunrise, Monday through Friday.

Plymouth County residents may request spraying of their area by phone (781-585-5450), fax (781-582-1276), drop off or mail (272 South Meadow Rd Plymouth, MA). A list of streets to be sprayed the following day will be updated by 2:30pm on our website: <http://www.plymouthmosquito.org/spray-routes-for-adult-mosquito-control.html>. Additionally, if an email is provided at the time of request, notifications will be sent prior to the application.

The purpose of our adulticide program is to control nuisance and/or virus carrying adult mosquitoes. The control materials used will be:

Duet ULV (EPA Reg. #1021-1795-8329) at a rate of .62 fl oz. per acre
Zenivex E4 RTU (EPA Reg. #2724-807) at a rate of .75-1 fl oz. per acre
Mavrik Perimeter (EPA Reg. #2724-478) at a rate of .5 fl oz. per 1,000 sqft
