

INVITATION TO BID

The Marshfield Board of Public Works, Marshfield, MA (the Owner), requests sealed bids for Redevelopment of School Street Well and Replacement of Well Pump, Contract 2018-08.

Sealed bids for General Contractor Work, endorsed "Redevelopment of School Street Well and Replacement of Well Pumping Unit, Contract 2018-08, Marshfield, MA" will be received at the office of the Department of Public Works, Town Hall, 870 Moraine Street, Marshfield, MA 02050, until 11:00 AM, on October 19, 2017, at which time and place bids will be opened publicly and read aloud.

The work includes, but is not necessarily limited to:

- a. Disconnect and remove the existing pumping unit, including electric motor, discharge head, baseplate and vertical turbine pump, column and shaft.
- b. Redevelop the gravel-packed well.
- c. Furnish new pump, column, shafts and associated bearings and couplings, driveshaft with guard (between the standby engine and right angle gear drive).
- d. Clean and paint the existing baseplate and discharge head.
- e. Install the pump, reusing the existing baseplate, discharge head, new right-angle gear drive, motor and associated shafts.
- f. Furnish and install a new surge relief valve with butterfly valve and associated piping and fittings.
- g. Furnish and install new pipe supports as required.

Pump removal, installation and well redevelopment shall be by a Massachusetts-certified well driller that shall have demonstrated experience in furnishing, installing and testing vertical turbine pumping units of comparable size. A licensed electrician shall reconnect power cables to the pump motor.

There will be a non-mandatory pre-bid meeting/site visit on Tuesday, October 10, 2017 at 10:00 AM at the well site, 88 School Street, Marshfield, MA. All prospective bidders are encouraged to attend to familiarize themselves with the site.

The work shall be completed within 90 days of notification of award of the contract. The station shall be out of service for a maximum of 60 calendar days during this period.

The Town of Marshfield reserves the right to reject any and all bids should it be in the public interest to do so, or to delete or reduce the scope of any work in order to bring the cost within available funds.

The successful General Bidder must furnish 100 percent (100%) Performance Bond and 100 percent (100%) Labor and Materials Bond.

MASSACHUSETTS GENERAL LAWS, CHAPTER 30S, 39M, AS AMENDED TO DATE APPLIES. Contract 2018-08 is subject to the minimum wage rates issued by the Commissioner of Labor and Industries, in accordance with Chapter 149, Sections 26 through 27D.

A deposit of \$50.00 (cash, company check or money order) is required for each set of Contract Documents obtained, made payable to Amory Engineers, P.C. Such deposit will be refunded if the documents are returned within 15 calendar days after Bid opening. No deposit is required for emailed documents. Requests for Documents to be mailed will be accepted if accompanied by a non-refundable payment of \$25.00, made payable to Amory Engineers, P.C.

Bid Security in the form of a certified check or bid bond, payable to the Owner, is required as follows: Five percent (5%) of the Bid amount.

Each bidder agrees to waive any claim it has or may have against the Owner, the Engineer, or their respective employees arising out of or in connection with the administration, evaluation or recommendation of any bid.
