

**INVITATION FOR BIDS

**PLYMOUTH AVENUE PUMP STATION UPGRADES

Pursuant to the provisions of Chapter 149, Section 44A-44J of the General Laws of the Commonwealth of Massachusetts (M.G.L. c. 149, §44A-44J), sealed bids from subcontractors for filed sub-bid categories (Masonry; Miscellaneous and Ornamental Iron; Waterproofing, Damp Proofing, and Caulking; Roofing and Flashing; Painting; Plumbing; Heating, Ventilation, and Air Conditioning; and Electrical Work) for the construction of the **PLYMOUTH AVENUE PUMP STATION UPGRADES, Contract No. 2024-01 (CWSRF #10375)**, will be received by the Town of Marshfield, MA, the Awarding Authority, at the website of Projectdog.com, until **2:00 P.M.** local time on **April 19, 2024**, immediately after which the bids will be published online. Sealed bids from General Bidders will be received at the website of Projectdog.com until **2:00 P.M.** local time on **May 3, 2024** immediately after which the bids will be published online on ProjectDog.

A non-mandatory pre-bid meeting will be held at the project site, 373 Plymouth Avenue, Marshfield, MA 02050 on **March 22, 2024 at 10:00 a.m.** Bidders are strongly encouraged to attend the pre-bid meeting.

Filed Sub-bidders shall be certified by DCAMM in the category applicable to the filed sub-bid. General Bidder shall be certified by the Division of Capital Asset Management and Maintenance (DCAMM) in *Sewerage and Water Treatment Plants or Pumping Stations*. Each Bid Proposal and Filed Sub-bid Proposal must include a Certificate of Eligibility in their respective category of eligibility.
