## Massachusetts Department of Public Health Arbovirus Surveillance Program Report

## Key Public Risk Communication Messages for This Week:

MDPH has reported 12 EEE positive mosquito samples from Hampden and Worcester Counties. In response to elevated EEE activity, MDPH increased risk levels in the region. Intensified surveillance activities are ongoing. MDPH also reports 128 WNV positive mosquito samples from Barnstable, Berkshire, Bristol, Essex, Hampden, Hampshire, Middlesex, Norfolk, Plymouth, Suffolk, and Worcester Counties and three WNV positive human cases. Intense precipitation events and average daytime temperatures will continue to support populations of mosquito vectors until a hard frost. Avoid mosquito bites by using EPA approved repellents, appropriate clothing and avoiding peak mosquito activity between dusk and dawn. Remove standing water by emptying containers and tarps.
