Key Public Risk Communication Messages for This Week:

MDPH has reported 23 EEE positive mosquito samples from Bristol, Hampden and Worcester Counties. In response to elevated EEE activity, MDPH increased risk levels in the regions. Intensified surveillance activities are ongoing. MDPH also reports 161 WNV positive mosquito samples from Barnstable, Berkshire, Bristol, Essex, Hampden, Hampshire, Middlesex, Norfolk, Plymouth, Suffolk, and Worcester Counties and three WNV positive human cases. Above average daytime temperatures will continue to support populations of mosquito vectors, posing a risk for human transmission. Avoid mosquito bites by using EPA approved repellents, appropriate clothing and avoiding peak mosquito activity between dusk and dawn. Remove standing water by emptying containers and tarps.
