2. Approval of the January 11, 2021 and March 10, 2021 meetings minutes

3. Green Harbor Pier Project update.

- Harbormaster is close to initiating a work order for final engineering and permitting - \$45,000 approved by Town
- Need to file Request for Determination of Applicability with Conservation to determine jurisdiction and permitting pathway for test borings
- Need to survey property lines
- Plan to file for all necessary construction permits together but the project will be completed in phases

4. Green Harbor dredging update

- Harbormaster Division working towards inner harbor dredging by October 2022.
- Harbormaster has been sending request letters to ACOE to dredge the "narrows" this spring.
- Harbormaster has been sending letters to State Reps requesting support for the dredging
- There are recent grounding reports by fishermen

5. South River dredging Update

- All necessary permits in place to continue the South River dredging project
- Dredging costs would be shared 25% from Marshfield and 25% from Scituate, the State will match with the remaining 50%
 - Bill Kerrigan moved to support grant funding request for South River Dredging
 - Roger Fosdick seconded the motion
 - Committee voted unanimously in favor
 - Motion carries

6. Harbormaster Report

- Plans to file a Notice of intent with Conservation for truck and large boat trailer parking in existing dredge spoils disposal area across the Street from Harbor Park on Joseph Driebek Rd.
- Boater safety courses will be scheduled by Mass Environmental Police to be conducted at the Maritime Center.
- Working to re-open shellfishing beds in the South River
 - o DMF is conducting weekly testing near the Scituate WWTP effluent
 - Dye study and dilution study needed

7. Other Business

• Mike Walsh reports that the Marshfield Commercial Fishermen's Association is also pleading with the ACOE for dredging o the narrows this spring.
